CED is moving decisively in the post-Internet system of information. Earlier episodes, trends, analysis, policy, implementation, action, alternatives on contemporary issues were only available in newspapers/magazines, hence CED's clippings system. Now all this is available in the form of websites- officials/alternative, blogs, emails, tweets and so on. Also these can be accessed in much more sophisticated ways than ever before. Increasingly so.

So, CED sees that its job is now to do the reverse: to make sense of the surfeit of information. But this cannot be done, across the topics. The need is to specialise on fewer issues and CED's outputs on those that are passionately felt about and that there is some kind of view and expertise. This is part of process of CED's resolution to "reinvent", as a more specialist, purposive, focussed, something that has been thought through, more dialogic, networked, user related, needs contribution, user contributed.

Summary of Activities

CED's activities have been the Information Hub of Documentation in two reference centres at Mumbai and Bangalore and on-line and offline databases. Besides bringing out educational information packages, the two centres have hosted meetings/workshops. These have been focused on the three main areas of Climate Change, Civil Society Concerns, Alternatives. The Bangalore premise has an archive of non-book material collected and documented for the last 35 years on contemporary issues.

Summary of Projects

INECC (Indian Network for Ethics in Climate Change): CED is a long standing member of INECC. Under this project CED has taken up a pilot study of vulnerability of urban marginalized communities in three locations of Bangalore; published a series of booklets, slides, webpages for Climate Education in local languages; creating awareness with youth and CSOs through workshops; is providing technical maintenance and content support for INECC website.

KICS (Knowledge in Civil Society): CED besides playing an active role in the forum, maintains KICS website. CED produced a video based on Rajni Bakshi's talk on 'Civil Society in the Marketplace of Social Business'. Two sharing sessions on Social Entrepreneurship were held during this period.

CED provided documentation services to Centre for Budget and Policy Studies(CBPS), Bangalore and installed its Eldoc package at CBPS.

Information Hub

CED as part of its effort to re-define itself in the Internet age, has started working on specific focus areas, and integrating its documentation and information collection efforts with the downstream work that needs to be done on each of these issues through networking and collaborating with other actors in civil society.

Focus Areas

Climate Change

For the last few years CED has been closely documenting the issue of climate change. While Climate change is a global phenomenon, the impacts, the vulnerabilities felt by the marginalised communities in different eco-regions at the local level needs to be studied. So the focus here is on livelihoods, natural resources, habitat - both rural & urban and adaptation. Water, energy, health, forests, transport, urbanisation and other infrastructure are also closely followed.

CED has been part of the larger network INECC (Indian Network on Ethics and Climate Change). INECC is a national network comprising of individuals and organisation representatives interested in the climate issue from a micro-macro perspective. It connects the issues of climate change to larger sustainable development and social justice concerns. In this context INECC perceives policy changes in favour of communities who are most impacted by the climate crisis.

New Economics

New Economics is a part of CED's on-going exploration of the meaning and practice of Structural Transformation. The thinking in the 'New Economics' stream is an important aspect of the global quest for systems that are socially just and ecologically sound.

While we continue to emphasise of theoretical positions relating to money, localisation, equity, aspects, we focus on those efforts which start with a social objective which mainly are NGOs, and Campaign organisations forced to go into business, rather than about some software, or technology which people think will make the changes. Though these are more numerous today, there is a substantial amount of Entrepreneurial effort coming from the activists.

There is very little thinking on the politics, except at the basic level of saying where is the community or what about the community or general equity issues. So what we need to learn here is that a) we need to delve deeper into how NGO and such enterprise programmes can be the nucleus of the alternative new democratic economy (New Economics – viewed from standard NGO eyes), b) document, research and encourage those efforts like CREAM who are training at the local level and c) CED would like to see its role as providing content, documentation, reference support for creating information sources, and education and reference material for such course.

Civil Society

Alternative Institutions & Development, Just Urbanism, Governance. These themes include society and change, gender and society, communalism, governance, food and agriculture, disasters, ecology and environment, human rights, health, children, media, urban issues, development and social change, survival and livelihood, civil society, alternatives in action.

Particularly issues of knowledge, information, science and technology relating to intermediary livelihoods & markets with a focus on localisation and diversity. In this work, we are closely engaged with Knowledge in Civil Society (KICS).

Physical Documentation:

CED's physical documentation has been marked by its unique and consistent collection of Clippings and non book materials. These are organised into issue areas rather than academic categories, which makes them popular with the non-academic information seeker including students, content writers for internet, films.

However given the good coverage of most issue on websites and access provided by Search engines, the emphasis has been more selective. For most of the year we scanned 11 newspapers, 14 magazines, 39 journals and 21 newsletters.

In the major review, we assessed that the selection can be done more judiciously and processing over and above the storage system if we have a shorter list of publications to scan.

From 1st March 2012 onwards we have reduced the subscriptions of newspapers, magazines, journals and newsletters. Some of the newspapers like Indian Express, Economic Times, Hindu, Mint and Magazines like Frontline, Outlook, Tehalka, Down to Earth, Terragreen and journals like EPW we follow.

In the year 2011-12, we have added 51 books, 40 reports and 2 videos to our collection. Also, Darryle D'Monte and Rajni Bakshi donated books which have been added to our library.

Electronic Documentation

With the growth of Internet, CED has had to re-orient its electronic documentation programme, in order to take advantage and leverage from information available through search engines, while still ensuring that critical development information from the perspective of the marginalised and equity, justice and environment are relived. During the year we have been developing systems to give more analytical information in the references and database such that users are able to find relevant material more easily in our website. This had been done with a view to provide more focused information, as part of CED's new information strategy.

CED's documentation is also available in electronic form. To provide easy accessibility we have built up the following database, which are used to search the databases and retrieve the

full documents both online and offline, in physical and in electronic form.

a) Electronic Documentation System (ELDOC): This is a database of electronic documents selectively sourced from different development sites. And this database also has documents from our more than 30 year old archives. This database has over 136400 records and can be accessed through our website.

b) Master Catalogue System (MCS): It is the database containing index of all the books, reports, journals articles films etc. available at CED. This has 44,000 records. This database is on line and the visitors to our website (www.doccentre.net) can access these. Users can do field based search and make bibliographies, as well as ask for the books, AV materials and articles.

c) Under DOCSWEB, we have organised a set of interconnected hyper linked documents on different themes.

Besides these, we generate content input to the various websites that CED manages and generates content for, these websites are:

CED website (<http://doccentre.net>): The website has an online searchable database of about 2 lakh records which includes the catalogue of books, reports, journals and electronic documents. Apart from these, we have also put the reports of various studies, the information outputs, PPTs and links to other networks. The website is used by members (with a login id and password) and also non-members.

Knowledge in Civil Society Website (<http://kicsforum.net>): CED provides both technical and content updating for this website. The main content of this website are the various KICS documents, workshop reports and other KICS activities.

SETDEV Website (<http://sntdev.kicsforum.net>): This is a separate website on Science and Technology is linked from KICS website. KICS was one of the lead partners in a three-year (2008-11) project “Science, Ethics and Technological Responsibility in Developing and Emerging Countries” (SET DEV), which was undertaken in order to support research systems and to encourage a socialization of scientific and technological research in India and Kenya. This website is a repository on Science and Technology for society.

Climate Change Website (<http://inecc.net>): CED being a part of the INECC network designed and maintains this website. This website has the documentation, publications, films, study reports, PPTs etc. that INECC and its partners undertake.

Video Documentation:

Video Documentation has become more important in CED since it is part of the strategic thrust on focused proactive documentation on specific issues. The video documentation captures the experiences and knowledge of local people and those in civil society and makes them available in different forms.

Climate Education Booklets in Local languages:


Balamaina Nirnayaalu: A Telugu translation of the booklet "Hardy Options: Eco-regional Notes on Climate Change and Semi arid regions" was done and printed.

The chapters includes - The Basics, Politics of Climate Change, The Semi arid region in general, Case study of Anantapur (which is a semi arid region) and What is to be done.

Vulnerability Assessment of Urban Marginalised Communities and Climate Change: Pilot study

CED took up this short-term study that focuses on the vulnerability of urban marginalized communities to Climate Change. We felt the need to

- understand what constitutes urban vulnerability in the context of climate change
- identify the links between general environmental degradation and urban vulnerability
- understand people's responses and capabilities.

The advisory process was instituted to enable scientists, researchers, and civil society to come together to sharpen the focus. The outcome of this study is a report on the vulnerability assessment in an urban ecosystem.

CED put in place a researcher, Hita Unnikrishnan with a masters in Life Science and also an activemember of the core team of Indian Youth Climate Network (IYCN), Bangalore Chapter working on issues of climate changes.



Vulnerability Assessment

CED

The study was deemed to be at three levels – a family level, a neighbourhood level and with certain specific occupational groups who directly or indirectly impact the global climate change phenomenon. The questionnaires were based on the outcomes that were previously enumerated through a brainstorming with the team and revised a number of times. The research design, Enumeration of the outcomes was put into place for the vulnerability study.

The study is drawn from the primary data that was collected at the individual, household level and neighbourhood level, along with a survey of secondary sources. Secondary data is sourced from the following sources – Slum Clearance Board, Slum Jagatthu, APSA, Janasahayog, India Water Portal, IISc, CIVIC, Institute for Social and Economic Change, Environment Support Group (ESG) and CED's documentation.

A stakeholder meeting was held in the last week of May 2011 to re-validate the findings from the vulnerability study. This meeting had representatives from the study areas and members of pro-active organizations working in the area of poverty alleviation and environmental degradation.

The aim of the study was not so much to determine the extent of the vulnerability but to understand the nature of it. While we were not able to separate the vulnerability to climate change from other intertwining vulnerabilities, it meant that we could explore the interlocking issues and learn about areas of adaptation that beyond climate change.



During this period we began collating material required for the Climate Education Booklet on Urban areas, which will be translated into Hindi. This work is in progress.

Voices of the Vulnerable: Speaking Climate Change to Durban and Beyond

Documentation including publication of the "Voices of the Vulnerable" a pre-COP Consultation organised by INECC at Fireflies, Bangalore, Nov 13- 15, 2011.

CED prepared the workshop banner in soft format and the workshop notes which presented the concepts of Vulnerability, a summary of the 3 case studies at the different eco-regions- Mountainous, Coastal and Urban. The workshop notes also contained the issues of REDD+, COP17 and Civil Society/ people's movements and a brief on the National and State Action Plans. 50 copies of the Notes were printed for the participants.



As part of the Video Documentation of the event, CED has video recorded the entire proceedings, based on which detailed transcriptions of the main speeches has been done. Soon after the consultation, a short report was prepared by CED for the climate change news letter, 'Eco-Ethic'.

Later, a more detailed report has been prepared. Further, a comprehensive webpage has been prepared for the event with links to notes of each session, various presentation made at the event and also to a few transcriptions of the lectures.

Durban: Negotiating to Nowhere

Critical Concern was brought out on "Durban Negotiating to Nowhere". These notes were compiled for the workshop on Climate Change & You... your Waste and shared with the students and CSOs.

The 17th Conference of Parties to the UN Framework Convention on Climate Change (COP 17) met in Durban in December 2011 to negotiate ways to drastically reduce emissions to keep the world safe from a catastrophic collapse. What they achieved at the end of several days of protracted negotiations was to push the world to yet another round of torturous and messy negotiations for a new treaty, protocol or legal instrument.

Under "the Durban Platform for Enhanced Action" the world agreed to negotiate "a protocol, another legal instrument or an agreed outcome with legal force" by 2012, to be implemented from 2020. Thus sounding the death knell of the basic principle of climate negotiations.

CLIMATE CHANGE Durban: Negotiating To Nowhere

The 17th Conference of Parties to the UN Framework Convention on Climate Change (COP 17) met in Durban in December 2011 to negotiate ways to drastically reduce emissions to keep the world safe from a catastrophic collapse. What they achieved at the end of several days of protracted negotiations was to push the world to yet another round of torturous and messy negotiations for a new treaty, protocol or legal instrument.

Under "the Durban Platform for Enhanced Action", the world agreed to negotiate "a protocol, another legal instrument or an agreed outcome with legal force" by 2012, to be implemented from 2020. Thus sounding the death knell of the basic principle of climate negotiations - Common but Differentiated Responsibilities (CBDR).

Lack of mention of any criteria for differentiation in "applicable to all" suggests that the notion of North-South differentiation will undergo substantial reformulation in the new agreement in favour of the North. Durban however preserved and expanded the protocol's more odious features; especially the gigantic racket called carbon trading, and moved towards bringing agriculture within its ambit after having done so earlier with forestry. The aim is to inject steroids into the carbon markets which have collapsed because of the great recession and because of the sub-prime loan style speculative trading. - (P Bidwai: Road to Nowhere)

Everything will be up for grabs, all principles will be reopened and all the old am-twisting and back room maneuverings will be back in full swing. But with one big difference: no developed-developing firewall, rather a single framework for all countries. - (D. Rajinmandan: Delhi Science Forum, Kyoto Negotiations Redux)

The political context for the inclusion of this term "applicable to all" in particular in the face of the conspicuous absence of the usual markers for differentiation — equity and common but differentiated responsibilities — makes it crystal clear that the goal posts on differentiation will shift post-2020. 

Seminars & Workshops

Assessing Social Enterprises: The need for New Parameters

CED along with KICS organised this as part of the research study to explore, understand and possibly evolve parameters for measuring the social impact of social enterprises in India, from a practitioner perspective.

In this consultative workshop, KICS researchers shared with social enterprises the initial findings on the subject. Joseph Satish made a presentation, Dr. Shambu Prasad, Joe Thomas, Rajni Bakshi, Inir were key participants.



The objective of this study is to explore, understand and possibly evolve parameters for measuring the social impact of social enterprises in India, from a practitioner perspective. We have been contacting a few social enterprises, preferably with a few years of operation for this study and have got a few encouraging responses. CED plans to follow up the contact with these enterprises into the larger framework of New Economics.

Wikipedia Academy Workshop

The first Wikipedia Academy in Mumbai was held in CED Mumbai, on October 1, 2011.

WikiAcademies are public outreach events aimed at engaging researchers, enthusiasts and subject experts who are not yet familiar with free and open knowledge, and the online wiki community. Using presentations and workshops, experienced Wikipedia authors and editors showed the participants how to contribute to Wikipedia, and orient the audience to Wikipedia's structures and community policies.



While open to all, this WikiAcademy was aimed at introducing Wikipedia's grassroots practices. There were about 22 participants at the workshop. Pradeep Mohandas, Vikram Krishna of Mumbai Wikipedia group were the main facilitators at this session.

Power in the Time of Climate Change



An Energy Workshop and Meeting with Civil Society Organisations was held on the 25th May 2011, as part of the CED-INECC project.

This consultation was facilitated by the Bangalore Platform and CED was supported by INECC, between energy experts and social activists to develop an

understanding of the energy scenario and link them to peoples issues in this regard.

The Steering Committee of the National Network on Energy which emerged out of the Bhubaneswar Conclave was part of this consultation. Shankar Sharma spoke of the gross inefficiency and inequality in power distribution. Consumers may not work to conserve or use energy efficiently in the name of Climate Change. Thus economic leverage has to be built into the system.

Shuba Raghavan, CSTEP said it is neither the technology nor the economics, but the institutional mechanisms that often stall large scale dissemination. There is a need for long term sustainable working of off-grid applications. T.Pradeep, IsquareD spoke of serious gaps in the Integrated Energy Policy, as far as rural energy. There is no mention of improved or energy-efficient stoves and there is also no mention of chimneys and ventilation in kitchens. Given that 85 million households use biomass as their primary fuel is a potential savings of over 500 million t/ce annually. He urged for the need for a looking at the Carbon Neutral Village as a platform for integrated energy. In the urban context, Hariharan, Eco-BCIL showed how energy usage can be reduced. BCIL builds top class homes where it is almost zero energy dependence where customers save 70% on energy bills. The issue of equity and justice is seldom spoken of in Energy terms when displacing large populations in the so called National Interests particular in energy development projects like big dams. Embedded costs need to be identifies and taken into account. On the other hand, Renewable energy is being over romanticized. Retro-fitting is also a big challenge.

This meeting was attended by about 21 people.

Vulnerability to Climate change in Urban Areas - a stake holders meeting

As part of the INECC program, CED has done a short-term pilot study that focus on the vulnerability of the Urban marginalised Communities to climate change. In order to share and validate the findings from the study, a stakeholder meeting was held on 28th May 2011, at CED Bangalore, This meeting was attended by the representatives of the study areas and members of the pro-active organisations working in the area of poverty alleviation and environmental degradation.

Veena and Hita presented the major findings of the study of mainly three slum areas - K S Gardens slum, EWS quarters Koramangala and Parappana Agrahara. This was followed by a discussion on these findings, where Sumi Krishna and Manjulika Vaz pointed out that the results are not so much quantifications of the occurrence or the incidence, but do provide episodic insights into the issues involved. There were about 16 people in this meeting.



Durban without Flying: an INECC-CED web meet

The activity “To Durban without Flying” was conceived and implemented by CED during the COP17, Durban conference, in collaborating with other INECC partners with a view to enable a low carbon method of local communities of youth and activists engaging with the



International climate negotiations process at low-cost.

After several experimentations CED worked out a system using the free/open source softwares and video streaming websites to have a webmeet between INECC members in Durban and participants in India.. One Climate network allowed us to use its equipment and bandwidth at Durban for this event.

In the run up to the event and as an integral part of the activity, a facebook page, and a module in the INECC website "Durban Links" was made specially to keep an update of various interesting news and development during the COP.

In all there were three live on-line events, two of which were INECC webmeets where there were live interaction between INECC members in Durban and participant at CED Bangalore and CED Mumbai. And the third event was a live compilation of events on the Climate Action Day on 3rd December, 2011.

Climate Change, Technology & Design: Challenges for Youth

Prof.T.Jayaraman, Professor and Dean, Centre for Science, Technology and Society, School of Habitat Studies, TISS, addressed youth at the Shristi School of Design, Yelahanka, Bangalore, March 30, 2012.



Prof. Jayaraman explained to the students that Climate Change is not to be confused with the Ozone layer. That certain amount of carbon-di-oxide is essential for life on earth. There are certain limits to it, not just for the atmosphere but the earth as a whole. If this limit exceeds it would do damage to flora and fauna, agriculture etc., and lead to consequences that are undesirable.

Technology & Design: Using the example of the popular kerosene pump stoves, they are dangerous, but still people prefer to use it. There is a better option made available by Indian Oil, both in terms of looks and easy use with a good blue flame, people still prefer to use the pump stoves. This is an area where design & technology plays a major role. He said that we can somehow dictate the way technology evolves. Looking at the history of patents, the history of design, not just the successful ones, not the ones that have made it to the market but the ideas that have ideated and made become economically viable.

Chairing this session Walter Mendoza said that Climate Change is increasingly being recognized as a development issue for many reasons. From a macro perspective it questions

the fossil fuel based development model that the world has been pursuing since the industrial revolution. This current development model is threatening the earth's sustainability and could have irreparable consequences. From a micro perspective the impacts of climate change affects those that are most vulnerable: the marginalized majority of the world.

Durban Disaster - where do we go from here?

What are the implications for future negotiations? and, for domestic policy and action?



This was a sharing session with Dr.T.Jayaraman, Dean of the School of Habitat Studies and Chairperson of the Centre for Science, Technology and Society, Tata Institute of Social Sciences and a former member of the Indian negotiation team at the COPs on March 30, 2012. The session was attended by CSOs in Bangalore.

Prof Jayaraman stressed the need for India to proactively help lead the way to an early global climate agreement ensuring that it is a fair and equitable deal. We need to push India from a total intransigence to something more positive, that has a more positive message, that we are serious about climate change. Given the vulnerability of the majority of its 1.2 billion population, an early climate agreement is as much in India's interest. India will eventually have to undertake commitment - a fair and equitable agreement.

Climate Change & You .. Your Waste:

Session with students of BMN College, Matunga, 11 Feb, 2012

Group of about 25 Home Science students from BMN college doing the Environmental science foundation course took part in this workshop along with another 12 students from St. Andrew's College.

John in his presentation ' Let's Try & Understand Climate Change' - gave an overview of climate change issues. Christopher and Denzil from Helms India demonstrated their compost drums, and showed practically how they have set up these non-smelly composting units in over 30 societies in Mumbai. Priyadrashini Karve from Appropriate Rural Technology Institute spoke on compact Bio-gas Plant as a solution to Urban Organic



Waste Management. Vaishali Gawandi from Medicinal Plants Conservation Trust, Pune spoke on growing medicinal plants in Pots.

This was followed by the question & answer session with students.

Session with students of Sophia College, 10 Feb 2012



Centre for Education & Documentation organized a session for students of Sophia College on Climate Change & Waste on 10th February 2012.

Students of the Economics department of the college attended the programme.

An Executive Exploratory Workshop for Civil Society-NGOs, ALMs, Housing Societies, Students, 10 Feb 2012 at CED, Mumbai

Walter Mendoza, who is involved with climate change issues for many years made a presentation titled 'Who's afraid of Climate Change, not the governments'. Christopher Pereira, from HELM Bandra spoke on Compost for building Societies. Priyadarshini Karve, from Appropriate Rural Technology Institute, spoke on Compact Bio-gas Plant as a solution to Urban Organic Waste Management.



CED Showed a film on Urban Agriculture where you can grow vegetables fruits on the terrace. Vaishali Gawandi from Medicinal Plants Conservation Trust spoke about Growing Medicinal Plants in Pots. Sheetal Shinde from Centre for Experimental Learning spoke on Climate Change & Urbanisation.

This workshop was organised in Collaboration with Rural Communes - Medicinal Plants Conservation Centre, Centre for Experiential Learning, Appropriate Rural Technology Institute, HELM –Bandra and INECC.

Other Development Educational Activities

Creating awareness with Youth: Materials for communication, dissemination

The dual language display has helped in making presentations of college youth who are not too savvy in English.

The visiting teams appreciated CED's effort to make use of the free technologies like skype and other communication technologies to have the online-session with our other centre in Mumbai..

The programme was held under the India Gateway Programme coordination by Christ University Bangalore, who evinced interest in continuing more formal links and exchanges with CED.

Visit by Keshav Gore Smarak Trust

The staff of Keshav Gore Smarak Trust, Goregaon Mumbai visited CED on November 24, 2011. They visited CED mainly to know and understand the various systems that CED uses for its documentation, including physical and electronic documentation. CED staff showed them the various systems that are used for documentation.

Organisational Development

In February, the key staff met for three long days. The main purpose of this meeting was to consolidate the various changes being perceived at CED especially in documentation work in the Internet era. Most importantly it was decided to revamp the documentation and information work from monitoring issues to a process that is capitalising the information, in the ongoing process of having information outputs, events, networking etc.

Capacity Building

Almost all the staff are trained to use the Content Management System and other collaborative tools for managing the content both for our regular documentation and also for the correspondence between our Mumbai and Bangalore centre.

These also enable us to manage the different websites including other organisation's websites. We continue to explore more in using various Audio Visual Systems - both hardware and

software - for online web meetings, video sessions etc.. We have been successfully using these systems along with skype on a daily basis to interact between our Mumbai and Bangalore office and also use this to assist our users visiting centres. We have developed capacity in using these open source/low cost technologies to have live sessions whenever there is an important event.

Cloud based filing system

A VPN based CLOUD system and storage was implemented, which provides ANYWHERE/ANYTIME access to our files/document on a common workshare/storage space. This enables us to access these from both Bombay and Bangalore CED and also from anywhere else. Apart from that, this system also helps to reduce the cost of maintenance and the administrative cost.

Collaborative notes/Wiki

Implementation of a wiki based Knowledge management/communication system again saves us time and also helped us to improve our document/notes sharing system, day to day Mumbai-Bangalore communication etc.. This along with the Cloud based system and SKYPE, has the potential to allow anyone to access our files and documents and thereby contributing to our documentation system remotely.

This year, we have also reviewed the whole system that we use in CED, and as part of this each of the staff members made presentation of their work.
