




## Annual Report 2021-22

### Introduction

Lockdown condition continued for most of this year. Work From Home (WFH) is the dominant work system and Webinars have become the dominant knowledge and information exchange culture. While this could have led to a broadening of access and opportunity, there are processes at work which privilege high speed, quick-fire opportunistic social processes. This includes the political process which has been driven to extremes thanks to dramatic, crowded and binarised agenda leaving little time and space for cross filtration of ideas, development of alternatives. On the social front too, entire communities which were easily labeled and stereotyped now reach cathartic antagonistic opposition. Just as one comes to grips with one aspect, another issue comes out.. along with simultaneous affronts on other issues, so much so that the social justice and change agenda keeps getting crowded. Therefore the “social dilemma” that was announced as a systemic cancer, is actually also being fueled by the major players of “reactionary” politics. Also endemic is the systematic exploitation of binarisation by social media models by hegemonistic economic and cultural economic fronts. There is no space to simultaneously step back, and build an alternative social education and civil participation model. CED once again sees its role as providing as a counter-information, or peoples knowledge space, not as adding to the existing information processing education and cultural system. CED’s role. But creating a working algorithm to counter the information polarisation, through decentralised networked IEC system. CED cannot be a “portal” of such a system, but needs to start a chain of such efforts, which builds of the current information flow, but slows it down, to bring “reflective” information and education in a non-monopolise space – be it the giant googled, and facebooks, or centralising issue based initiatives. The task is more difficult because people seem to be socialised into the model, they are made to believe as active agents, lobbyist in the old regime, and “disruptors” in the current scenario.

Given this external environment, CED’s activities focused on what it could do under Work from Home, particularly in the digital space. There was also continued pressure on finances, due to uncertainties of legal frameworks, donor preferences, and implementation impediments due to COVID and the changing education and referencing scenario.

Our website [www.doccentre.net](http://www.doccentre.net) whose purpose was to document development over three information decades is a catalog, outside the dominant search engine system, of our curated physical library collection. But it also bridges into the digital, as it makes accessible selective information online, while pulling the more serious researcher to the physical collection.

Then with the long and winding road to structural transformation, (www.lnwr.in) we have been experimenting and developing curated information which can serve as knowledge to the socially engaged (rather than the researcher) students, young professional, social worker, concerned citizen. It is this in view that Given the current rush of Information, Education and Communication (IEC) technology, we adopted the perspective of slowing down knowledge in the form of video documentation of campaign & mobilisation meetings, middle level seminars of activist and social practitioner and as well as in-depth interviews with the field level activists and social workers. The main documentation, centers around ongoing values, analysis, prescription and responses to social change, development, social justice.



Given the new IT environment, the main emphasis was to shape the e-library system with the minimum of costs. The task was to populate and curate the E-Library with information and analytical sources, using links to online sources wherever possible while creating an annotation for the main target audience of CED namely the young activist, student, social and development worker and content creator.

Thus, the documentation system of CED... must deliver access in a manner which while not being neutral, is critical. Everyone is putting out content, from the highly academic to the in-your-face argument. While there is no need to more content, the task is again to organise critical bits into slow, reflective process, even as one is engaged. The information plethora is omniscient yet crowded mainly because search agents and BOTs have taken over. The film Social Dilemma aptly describes how the economics of data moves it in a way leads to polarisation - "to him who opines, more shall be given"

Now any organisation is able to create its content, and propagate its ideas, analysis, actions, and future vision - but the current social media throws them into a) instant short reactive messaging, most of which get disaggregated from the organisations goals and mobilisation.

b) Move towards hierarchical communication - of Webinar.. rather than work-groups, and work-shops, each bring in heavy weights into the discourse.

c) mobilisation also tends to get vertical, rather than horizontal, as immediately gains of organisations of on the carrot stick of social media.

The competitive political scenario also gives each one an illusion that they are actively in one camp or the other, when there is only a virtual

### Designing New Shared Systems transiting from physical Documentation to E- Library & On-line self-learning

Thus CED has been trying to evolve its systems, such that it brings together, not in a portal manner, but more as a network of informations nodes, each having it own flavour, and emphasis, yet relying on each other for sharing and systems.

The Long & Winding Road website is a separate Joomla-based website: lnwr.in, which is based primarily on direct documentation in AV form of events and interviews of people in the NGO and Social Sector space. This involved four steps of documentation: (1) Video Documentation of events, interviews, lecture as creation of content, (2) Making AV modules and uploading them in a public domain space, like youtube. We have now added a e-library system, which takes this documentation further by (3) Creating webpages and notes for publishing on websites and (4) outreach the content through social media platforms like facebook, whatsapp, email groups.

The latest site that we are working on is emeets.lnwr.in, which contains over 1700 articles organised into 1. E library 2. Blog. 3. Docsweb & 4 Letters. The mining of these articles are from social media and emeets among NGO groups, activists, engaged professionals, teachers, social workers etc.

We are using a curated Blog model for specific topics like Ahimsa, Climate Change, COVID. By default, each blog and e-library is latest first. This is because we do not have the person-power to process every document that we put into the system. So at the first level we just enter the article, classify it into main categories. To enable it to be access using the e-library menu which then shows up in reverse chronological order.

At the next level, we break up each category into sub-categories, and re-classify the article, and re-order the articles to show up in a blog to make for a better ordered read. This is possible to do on a batch processing basis, rather than an ongoing daily basis. It is designed such that this can be done on-line by volunteers, interested persons.


Seminar on Pew Survey of Religion: Five videos. Internal training on Sufism, Omar Kayam, two videos.

Due to COVID restrictions, video recording has been restricted to on screen recording of seminar content. A few of them have been segmented in lieu of editing from online and converted into posts and/or article within different Blogs. In addition to generating our own content, we are experimenting with valourising third party videos to bolster documentation/information modules.

### Making available physical Documentation in hybrid mode

The old database search programme which integrated the online and off line documentation needs to be upgraded as the old software programming is outdated. Further there is a heavy cost of maintaining data servers on-line. Given that library staff has been withdrawn, access to physical documentation is planned in a semi-automatic mode. We have been working to update software, and develop low maintenance hybrid systems for the physical documentation.

Working on a system to integrate old on-line documentation in the new readymade CMS system - as part of the e-library, and the special blogs, and Letters / LMWR section. The category programme as well as data maintenance. This process has been started to simplify the systems into ready available and upgradeable



## MediaLabs

In view of COVID restrictions, this programme is being redesigned. A system of Open Course on Media and Development is being designed, based on the documentation model of syllabus, and flexible interactivity. Exercises are being documented in the cloud. A blog to link to reading material and course content is also being populated in the Slow Post website at least for the time being. Progress on this is slow, as WFM is not conducive to critical development of this.

## Outreach

The main system of Outreach has been to create posts linking to different blogs and documents, and circulating them on different social media groups, we are a part of. Since March several posts have been made on Whatsapp and Email, linking them to themes being discussed in those groups.

Ahimsa Conversations upto this financial year every week without fail taking the tally of 56 episodes to 108. Ahimsa Conversations was launched on Mahatma Gandhi's martyrdom day, January 30th, 2020. March end 2021 -- 56 episodes. Two years later there are 100 episodes online with speakers from 22 countries. This is an almost solo effort of Rajni Bakshi. Thanks also to viewers and those who have subscribed to this channel.
